- Qualification Level: This certificate is a level-3 vocational qualification on the UK Regulated Qualification Framework (RQF) and Qualifications and Credit Framework (QCF), comparable to an A-level. In the Scottish Credit and Qualification Framework (SCQF), it is recognized as a level 6 with 7 credit points.
- Study Requirements: The course requires a total of 67 study hours, divided into 34 taught hours, 25 self-study hours, and 8 assessment hours



Course Structure

- The course covers the following elements, each with designated learning and self-study hours:
- Foundations in Environmental Management (6 learning hours, 25 self-study hours)
- Environmental Management Systems (5 learning hours, 25 self-study hours)
- Environmental Impact Assessments (6 learning hours, 25 self-study hours)
- Planning for Environmental Emergencies (3 learning hours, 25 self-study hours)
- Control of Emissions to Air (2 learning hours, 25 selfstudy hours)
- Control of Environmental Noise (2 learning hours, 25 self-study hours)
- Control of Water Contamination (3 learning hours, 25 self-study hours)
- Waste and Land Use Management (4 learning hours, 25 self-study hours)
- Energy Sources and Efficiency (4 learning hours, 25 selfstudy hours)

Assessment

The NEBOSH Environmental Management Certificate includes two assessments:

- 1. **Unit EMC1:** An open book exam completed online within 24 hours, involving a case study and task-based questions to test practical application of knowledge.
- 2. **Unit EMC2**: A practical risk assessment involving the identification and evaluation of environmental aspects and impacts in your workplace, based on ISO 14001:2015 standards. This assessment is divided into four stages: introduction, identification of aspects and impacts, significant aspects and recommendations, and communication and review.
